Of our consideration:

We have undertaken a review of the following aspects of Banco de Chile's Greenhouse Gas Emissions Reduction Statement for the period 2022.

Scope

Banco de Chile has asked Deloitte to review the Greenhouse Gas Emissions Reduction Statement for the period 2022.

This report contemplates the reduction of paper consumption (ton) and the reduction of energy consumption (MWh) of the offices belonging to Banco de Chile at national level through the implementation of a replacement of office printers, for the period between January 1, 2022 and December 31, 2022.

The total reductions in Banco de Chile's Greenhouse Gas Emission Reduction Statement 2022 are shown in Table 1.

Methodology

Our review of the Greenhouse Gas Emission Reduction Statement, period 2022, was conducted in accordance with the guidelines of ISO 14064-2:2019. It should be noted that this verification does not constitute an audit and, accordingly, we do not express an audit opinion on this statement. The review process considered the formal receipt of information, in addition to the verification activities performed through analytical procedures and review tests described below:

- Receipt of Excel document with calculations and Greenhouse Gas Emission Reduction Statement, as well as folders with information and calculation evidence.
- Review of the consistency and coherence of the Greenhouse Gas Emission Reduction Statement calculations.
- Review of the information and data consistency in Banco de Chile's Greenhouse Gas Emissions Reduction Statement.


Conclusions

- Nothing has come to our attention that causes us to believe that Banco de Chile's Greenhouse Gas Emission Reduction Statement has not been prepared in accordance with applicable international standards.
- All inconsistencies found have been clarified and improved, therefore, nothing has come to our attention that causes us to believe that the information provided on the Greenhouse Gas Emission Reduction Statement contains significant errors.

Responsibilities of Banco de Chile and Deloitte

- The Greenhouse Gas Emission Reduction Statement elaboration, period 2022, as well as its content is Banco de Chile's responsibility, which is also responsible for defining, adapting and maintaining the management and internal control systems from which the information is obtained.
- Our responsibility is to provide an independent report based on the procedures applied in our review.
- This report has been prepared solely in the interest of Banco de Chile in accordance with the terms of the Letter of Engagement.
- The conclusions of the verification performed by Deloitte are valid for the Greenhouse Gas Emission Reduction Statement, period 2022.
- The scope of a limited assurance review is substantially less than that of a reasonable assurance audit or review. Therefore, we do not provide an audit opinion on Banco de Chile's Greenhouse Gas Emission Reduction Statement Period 2022.
