We have performed a limited assurance engagement review of the key performance indicator associated to the Greenhouse Gas Emissions for the period ended as of December 2023 of Banco de Chile (hereinafter "the Bank"), in accordance with the Greenhouse Gas Protocol Standards (hereinafter "GHG Protocol"). This report includes the verification of the Corporate Carbon Footprint of the Bank.

Standards and Assurance Process

Our responsibility is to express a limited assurance conclusion on the key performance indicator associated to Greenhouse Gas Emissions for the period ended as of December 2023 based on the procedures that we have performed and the evidence we have obtained. We conducted our limited assurance engagement in accordance with International Standard on Assurance Engagements on Greenhouse Gas Statements (ISAE 3410), issued by the International Auditing and Assurance Standard Board (IAASB). This standard requires that we plan and perform this engagement to obtain limited assurance about whether the key performance indicator associated to Greenhouse Gas Emissions for the period ended as of December 2023 is free from material misstatement.

A limited assurance engagement involves performing procedures (primarily consisting of making inquiries of management and others within the entity, as appropriate, and applying analytical and other procedures) and evaluating the evidence obtained. The procedures also include assessing the suitability in the circumstances of the Bank's use of the applicable criteria as the basis for the preparation of the key performance indicators associated to Greenhouse Gas Emissions for the period ended as of December 2023.

Our review included the following procedures:

- Meeting with the team that led the process of preparing the key performance indicator Greenhouse Gas Emissions.
- Obtained the spreadsheet with the key performance indicators as well as the information and evidence that support the key performance indicators.
